Immigration procedure fees for 2017



The government has published the amounts of the immigration procedure fees that will be applicable in 2017. These amounts must be paid for all immigration processes carried out with the National Immigration Institute (INM, Spanish acronym).

Please find below a table with the new Mexican peso fee amounts applicable for the most common immigration procedures:

Authorization to perform paid activities for a Temporary Resident or Student Temporary Resident	\$2,789.00
APEC Business Travel Card	
For review, processing and, if applicable, issue of the APEC Business Travel card (ABTC)	\$1,228.00
